## **Who is Eligible to attend Teen Day ?**


- ◆ Youth who are currently in foster care, age 14 and older OR
- ◆ Youth who were in foster care and went into legal guardianship or were adopted *after their 16th birthday*



\*Until December 1st, youth who have never come to Teen Day will be given 1st priority. If there are seats available after the RSVP date, the event will be open to youth who have attended prior Teen Days.

# Map & Directions

## Ronald T.Y. Moon Kapolei Courthouse



The courthouse is located at 4675 Kapolei Parkway, Kapolei.

The easiest way to get there from Honolulu is to take **Exit 1** off of the H-1 freeway. Follow the road as it veers to the right, goes back over the freeway and down the hill. Next, take a left at the first traffic light. Drive by Costco. When you come to the stop light, turn right. The entrance to the Courthouse will be on your left.

Coming from Waianae, take **Exit 1A**. Follow the road as it veers right and take a left at the first traffic light. Drive by Costco and turn right at stop light. The entrance to the Courthouse will be on your left.

The event begins on the third floor in the Multipurpose Room. There will be signs directing you to the room.

*Parking is in front of the courthouse and is 100% metered.  
Bring lots of quarters as parking meters only take quarters.  
Each quarter gives you 30 minutes, max 4 hours at a time.*
