## Child Welfare & Student Support Initiatives



Highlights from the 2024–2025 school year include key initiatives by the Hawai'i Department of Education (Department) to strengthen support for students in foster care. In partnership with the Department of Human Services (DHS), the Department formalized new data-sharing and procedural agreements, co-led statewide trainings on educational stability, and hosted a Child Safety Conference focused on child maltreatment, educational equity, and cross-sector strategies to support student well-being.

#### 1. Memorandum of Agreement (MOA)

Ensuring Educational Stability for Children in Foster Care in Hawaii Effective: April 29, 2025

The Department and DHS established a Memorandum of Agreement and joint procedural guidance outlining shared responsibilities to ensure the educational stability of students in foster care.



#### **Key Provisions:**

- Best Interest Determination (BID): A collaborative decision-making process to determine the most appropriate school placement for a student entering or changing foster care placement.
- Immediate Enrollment: No student is denied or delayed enrollment due to incomplete records.
- Transportation Coordination: The Department and DHS ensure timely access to schools.

#### Implementation Support:

The Department and DHS conducted statewide in-person and virtual training sessions in June and July 2025, reaching over 200 school and CWS staff to support consistent implementation.

# 2. Memorandum of Understanding (MOU) Data Sharing to Support Students in Foster Care Effective: March 7, 2025

This agreement enables secure, timely data sharing between the Department and DHS to support academic continuity, enhance coordination between educators and caseworkers, and ensure compliance with federal mandates such as ESSA, FERPA, and CAPTA.



#### **Data Sharing and Technical Specifications Agreement (DSTSA)**

The accompanying DSTSA outlines the specific data shared (e.g., attendance, grades, placement details), authorized users, and privacy protections.
